**Application No. 556-07 ES, Cedar Hill Cemetery, 453 Fairfield Avenue, Hartford Parcel 025-001** Application for construction of roadway, storm drains and detention ponds for Cemetery Expansion. Also seeking erosion and sediment control plan certification.

Corey Garro of Close, Jensen & Miller, PC represented the applicant. William Griswold, of Cedar Hill Cemetery was present. Mr. Garro presented the drawings and explained the proposed roadway which provides access to the areas for future burials within the Cedar Hill Cemetery.
