### Town Manager's Report

Finally, a little break from the oppressive heat and humidity. It has been a very busy week of meetings here at town hall. The Town Council had their regular meeting this past Monday evening. Chris Traczyk presented the Wethersfield Tourism and Cultural Commission's annual update. There were several exciting initiatives that the commission is working on to further promote our great Town.

Police Chief Rafael Medina presided over a ceremony to promote Gustavo Rodriguez to the rank of Deputy Chief. Deputy Chief Rodriguez has served the department for several years and also had a distinguished career with the Hartford PD prior to coming to Wethersfield. I am very confident that he will thrive in his new position. Chief Medina also promoted Brando Flores to Sergeant. Sgt. Flores is a military veteran, former state corrections officer and former Hartford PD officer and has been a dedicated member of the Wethersfield police department since 2021. He will be a valuable addition to the leadership of the department. In addition to the promotions, Chief Medina introduced new Officer Ian Luna. Officer Luna is a lifelong Wethersfield resident and serves in the Army National Guard as a military police officer. He also served as a New Britain Police Officer. His experience and knowledge of the community will be a great asset to the department. Finally, Chief Medina also introduced two new officers who just completed their training on July 11th. Officers Eric Peck and Kyle Wellington join the Wethersfield Police Department. Both of these new officers have excelled in their training and are excited to begin their public safety careers here in Wethersfield.

Chief Medina also provided the Council with a detailed annual statistical report of the department's performance over the past fiscal year. The Chief noted that the Wethersfield Police Department has one of the lowest crime rates in our region, which is a testament to the dedication and commitment of all of the men and women who serve in the Wethersfield Police Department. Thank you all for all that you do!

Also, during the Council meeting, the Council received a presentation from Luke McCoy from Kaestle Boos Associates, Inc., our consultants on the Mill Woods Park Master Plan update. Residents will be hearing more about this work and have opportunities to provide their thoughts and priorities for the park's future.

The Town Council also authorized the issuance of a request for proposals for consultant services to examine options for improvements to our elementary schools. This project will provide services to assist the town in developing scenarios and cost estimates for the phased improvements of our elementary schools.

Peter Leombruni was elected Vice-chairman and Anthony Homicki was elected Clerk. ## **CENTRAL CT HEALTH DISTRICT**

West Nile Virus Positive Mosquitoes and Birds Detected in Wethersfield

The State of Connecticut's Agricultural and Experimentation Station (CAES) performs mosquito trapping and testing starting at the beginning of June and ending in late October. Arboviruses tested at CAES include West Nile Virus (WNV), Eastern Equine Encephalitis virus (EEE) and Jamestown Canyon Virus (JC). This afternoon (July 15) the District was notified by the Connecticut Department of Public Health that sampling from the previous week at the Goff Road test site in Wethersfield yielded WNV positive mosquitos.

According to the Center for Disease Control and Prevention (CDC), most people (8 out of 10) infected with West Nile virus do not develop any symptoms. However, about 1 in 5 people who are infected develop a fever



with other symptoms such as headache, body aches, joint pains, vomiting, diarrhea, or rash. Most people with febrile illness due to West Nile virus recover completely, but fatigue and weakness can last for weeks or months. About 1 in 150 people who are infected develop a severe illness affecting the central nervous system such as encephalitis (inflammation of the brain) or meningitis (inflammation of the membranes that surround the brain and spinal cord). Symptoms of severe illness include high fever, headache, neck stiffness, stupor, disorientation, coma, tremors, convulsions, muscle weakness, vision loss, numbness, and paralysis. If anyone is experiencing any of these symptoms, the Health District encourages them to seek care immediately with their medical provider.

### ENGINEERING

- Mill Woods Park Dam Improvements: The Town Council has approved award of a contract to All Seasons Landscaping from Cheshire CT for construction of dam improvements at the Mill Woods Park Pond and Swimming Pond. This work is mandated by the CTDEEP Dam Safety Unit and primarily includes removing trees and root balls on or in close proximity to the dam embankments, installation of slope stabilization and erosion control measures, and concrete and pipe joint repairs. At this time, we anticipate that work will commence in August with completion this fall.
- Railroad Track Road Crossing Repairs: Genesee & Wyoming Railroad notified the Town that their contractor is scheduled to start repairing pavement along the railroad track crossings at Hartford Ave, Jordan Lane and Wells Road in late-summer.
- LOTCIP Wolcott Hill Rd Reconstruction: A new "Welcome to Wethersfield" sign has been installed at the north end of the island near the Hartford town line, which is being protected by white bollards mounted to the road surface and large, concrete planters. The two streetlights that were hit by a vehicle will be replaced by the Physical Services Dept.
- **MDC Northbrick Ln Water Main Replacement:** MDC's contractor, Paramount Construction, began replacing the water main along Northbrook Ln this week. Pipe materials ill temporarily be immediately stored along the road in the North brick Green. This work is expected to take approximately 2 weeks to complete.
- **MDC Goodrich Dr Water Main Replacement:** Staff is currently reviewing plans for MDC to replace water mains throughout this neighborhood that is located near Hartford to the west of Wolcott Hill Rd. This project follows recent gas main replacement project by CNG. The utility companies will be coordinating to repave the disturbed surfaces upon completion of this work.
- **CNG Stillwold Dr Area Gas Main Replacement:** CNG's contractor is currently working in the area of Stillwold Dr, Ruscan Rd, Lindberg Dr and Byrd Rd to replace gas mains and services.
- **CNG Fairview Dr and Hillcrest Ave Gas Main Replacement:** CNG's contractor has completed gas main replacement work in this area and expects to complete remaining service replacements next month.
- **CNG Griswold Rd Gas Main Replacement:** CNG's contractor has completed gas main replacement work in this area and expects to complete remaining service replacements next month.
- **CNG Edward St Gas Main Replacement:** Barber Utilities has completed gas main replacement work in this area and plans to replace services by the end of this year.

- Pavement Preservation Program: The Town's contractor, indus, has completed all crack seal and most fog seal work along local roads. Due to conflicts with a DOT contractor working on the I-91 overpass crossing Middletown Ave, the remaining fog seal work along Middletown Ave and Mill St will be completed next month. These preservation measures help to preserve the integrity and extend the service life of the pavement surfaces.
- **Pavement Marking Program:** The Town's contractor, Atlantic Pavement Markings, is completing pavement marking work along local roads. They have been directed not to apply glass beads to freshly painted crosswalks to minimize the potential for slips and falls since they can make the road surface slippery soon after application. The Physical Services Dept staff will be painting the parking lots at Town facilities this summer.
- **Spring Paving Program:** The program is complete. General Paving will return to top dress lawn restoration areas in the fall when the temperatures are cooler during the growing season.
