**The Town of Wethersfield Code Chapter 139-1 requires that owners of properties bordering upon any street where sidewalks are present shall keep such sidewalks free from all obstructions which would endanger the safety, health or well-being of pedestrians. For residential property owners that qualify, local funds may be available for sidewalk repair or replacement by the Town. These funds may only be used to eliminate safety hazards within the public right-of-way by repairing or replacing sidewalk slabs, and are only available to property owners who have a demonstrated financial need for assistance.**
